#### **INFORMATION**

- 1. Candidates who wish to apply for more than one category of posts should submit separate application.
- 2. SUBMISSION OF MORE THAN ONE APPLICATION FOR ONE PARTCULAR POST IS STRICTLY FORBIDDEN. THE CANDIDATURE OF A CANDIDATE, WHO SUBMITS MORE THAN ONE APPLICATION FOR ADMISSION TO THE SELECTION PROCEDURE, WILL BE CANCELLED EVEN IF HE/SHE IS ADMITTED TO THE SAME.
- 3. The 'qualifications for direct recruitment' prescribed in the advertisement are as per the notified recruitment rules issued by Government.
- 4. All the degrees/ diplomas/ certificates mentioned in the advertisement must have been obtained only from Universities/ Institutions duly recognized by the competent authorities.
- 5. The prescribed 'qualifications for direct recruitment' are the minimum and mere possession of the same does not entitle applicants to be called in for the Interview. Where the number of applications received in response to the advertisement is large and it is not conveniently possible to interview all the applicants the Selection Committee may restrict the number of candidates to be called for interview to a reasonable limit on the basis of either higher qualifications /higher marks/grade obtained or **on the basis of a Screening Test.**

IN THE CASES OF SCREENING TEST, CANDIDATES SUFFERING FROM BLINDNESS OR LOW VISION AND LOCO-MOTOR DISABILITY OR CEREBRAL PALSY WITH WRITING EXTREMITY WILL BE ALLOWED THE HELP OF A SCRIBE, IF REQUIRED. THE SCRIBE SHOULD NOT POSSESS EDUCATIONAL QUALIFICATION HIGHER THAN THE REQUISITE QUALIFICATION FOR THE POST.

If sufficient number of candidates with prescribed age limit is available for selection for a particular post, the Selection Committee may exercise its discretion not to relax upper age limit of the candidate(s) even if the provision for such relaxation is laid down in the advertised criteria.

#### 6. The benefits of reservation of vacancies are admissible to:

- (i) S.C./S.T./O.B.C.(non-creamy layer) candidates of West Bengal only. The S.C./S.T./O.B.C. Candidates of other States shall be treated as general candidates.
- (ii) PwBD (with disabilities 40% and above).
- (iii) Economically Weaker Section (EWS) candidates of West Bengal. EWS candidates of other state shall be treated as general candidates.
- (iv) E.C Exempted Category: Shortlisted Candidates applying under Exempted Category (E.C.) as a member of the family of Land Losers / as Ex-Census Employees/Election Job Workers/Enumerators should produce original copies of Registration Certificates issued by the Director/ Joint Director of Employment, Government of West Bengal at the time of scrutiny before the Interview. In case of non-availability of suitable E.C. candidates, the said vacancies shall be filled up by non-E.C. candidates under the same broad category.

N.B.: Reservation of vacancies will be made as reported by the Govt.

#### 7. Relaxation In Age Limit

i. The upper age limit is relaxable by 5 years for S.C. & S.T. candidates and by 3 years for O.B.C. (non-creamy layer) candidates of West Bengal. In the case of Persons with Benchmark Disabilities (PwBD), the upper age limit is relaxable upto 45 years. The upper age limit is also relaxable for Ex-servicemen as per existing Government Rules.

Note: The Ex-serviceman candidates, if shortlisted, have to produce relevant documents regarding service rendered by them, in original, in support of their claim for Age Relaxation at the time of verification.

- ii. No relaxation is applicable to S.C./S.T./O.B.C. candidates of other States as they shall be treated as general candidates.
- iii. No claim for being a member of S.C./S.T./O.B.C.(Non-Creamy layer)/PwBD will be entertained after submission of the application.

## 8. Particulars and Certificates Required

1. A candidate claiming to be EWS/S.C./S.T./O.B.C. (Non-Creamy Layer) or Persons with Benchmark Disabilities (40% and above) must have a certificate in support of his / her claim from a competent authority of West Bengal issued on or before the closing date of submission of application as specified below and no claim in this regard will be entertained afterwards. In case, a candidate is unable to produce the relevant valid certificate in support of the declaration/claim made by the candidate at the time of document verification, his/her candidature will be summarily rejected.

## (a) For S.C., S.T. & O.B.C.(Non – Creamy Layer) Candidates :-

i) In the district, the Sub-Divisional Officer of the Sub-Division concerned, and

ii) In Kolkata, the District Magistrate, South 24-Parganas or such Additional District Magistrate, South 24-Parganas, as may be authorized by the District Magistrate, South 24-Parganas, on behalf and the District Welfare Officer, Kolkata and Ex-officio Joint Director, Backward Classes Welfare.

iii) OBC (Non - Creamy Layer) candidates must submit their renewed / revalidated certificates regarding Non-Creamy Layer Status prior to interview and at the time of appointment as per existing Govt. Rules.

## (b) For Persons with Benchmark Disabilities (PwBD) :-

A Medical Board constituted at Government Medical College Hospitals in Kolkata, District Hospitals and Sub-divisional Hospitals as per extant provisions laid down in RPwD Acts & Rules.

## (c) For EWS Candidate:-

The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by any of the following authorities:-

(i) In the District, Additional District Magistrate in charge of development matters of the District Concerned.

(ii) District Welfare Officer, Kolkata and Ex-officio Joint Director, BCW&TD in respect of Kolkata for Kolkata Municipal Corporation Area. [in terms of PAR Department 325-PAR(AR)/3P-1/2019 dated 09.07.2019, read with BCW Department Memo No. 959-BCW/MR-52/2019 dated 18.05.2023]. However, any EWS certificate issued in favour of a candidate by the erstwhile authorities as mentioned vide said P&AR Department notification will also be allowed if found valid.

(iii) EWS candidates must submit their renewed/revalidated certificates regarding EWS status prior to interview and at the time of appointment.

2. The **'Selection Committee'** may require such further proof of particulars from the candidates as it may consider necessary and may make enquiries about their character and other particulars regarding suitability and eligibility.

9. CANDIDATES MUST FULFIL THE QUALIFICATIONS BY THE CLOSING DATE.

10. All requisite certificates regarding educational qualifications, proof of age, other relevant experience certificates and other requisite documents must be furnished as and when required by the 'Selection Committee'.

11. If at any stage even after issue of a letter of recommendation for appointment a candidate is found ineligible in terms of the advertisement his/her candidature will be cancelled without further reference to him/her.

12. CANVASSING IN ANY FORM WILL DISQUALIFY THE CANDIDATE.

16. Please note that the above procedure is the only valid procedure for applying. No other mode of application or incomplete steps would be accepted and such applications would be rejected.

17. Your Online Application will not be registered unless you upload your Photograph, signature and certificates as specified.

- a. In case the face in the photograph or signature or certificate is unclear / smudged the candidate's application may be rejected.
- b. After uploading the Photograph / signature/ certificate in the online application form, candidates should check that the images are clear and have been uploaded correctly. If the photo is not uploaded at the place of Photo, application will be rejected. Candidate himself/herself will be responsible for the same.
- c. Candidate must ensure that Photo to be uploaded is of required size and the face should be clearly visible. Candidates should ensure that the signature uploaded is clearly visible.
- d. The Photograph should be without cap and dark lens spectacles. The frontal view of the face should be clearly visible.
