### **VERIFICATION GUIDELINES FOR THE INSTITUTES**

#### WHILE ALLOWING PROVISIONAL ADMISSION OF THE CANDIDATES

(Academic Session 2024-25)

#### **ONLY FOR FINAL ALLOTMENT**

This REVISED Verification Guidelines has been prepared based on the earlier circulated guidelines and on the basis of outcome of the discussions of VC held on 01.07.2024 through Google Meet with the institute authorities.

The Council prepared two Merit Lists for admission of students during the academic session 2024-25, one for 1<sup>st</sup> year of Diploma Courses and the other for 2<sup>nd</sup> year of Diploma Courses through Lateral Entry Scheme. Council also issued Provisional Rank Card to all merit listed candidates. The online counselling for admission of candidates is being made based on the aforesaid two Merit Lists. The allotment of seat to a provisionally merit listed candidate will be made based on the General Rank, vacancy position at his/her rank, choices and priority filled up by him/her during counseling.

#### **IMPORTANT:**

- 1) The marks of Qualifying Examination along with other details, which were submitted by the candidates during their application through the online portal of the Council, have been considered for preparation of the aforesaid merit lists. Therefore, the marks obtained by a candidate in the qualifying examination has to be checked at the institute level before taking their final admission. For the purpose of verification of marks, two separate merit lists (For 1st and 2nd Year Admission) are attached herewith showing the marks of Qualifying Examination submitted by the candidates during application. During such verification, if it is found that the marks provided by a candidate is more than what he/she has actually obtained as per his/her marksheet, then his/her provisional admission will be cancelled. But if the marks provided by him/her is less than that he/she has actually obtained, then his/her admission may be allowed.
- 2) For 1st year admission, aggregate marks obtained by a candidate excluding Additional / Optional subject, marks obtained in Mathematics and Physical Science / Science in Qualifying Examination, have been considered for preparation of the merit list, while for 2nd year admission, aggregate marks obtained by a candidate excluding Additional / Optional subject in Qualifying Examination has only been considered for preparation of the merit list.
- 3) The candidates must pass their Qualifying Examination from the Recognized Board / Council listed below.

In addition to verification of the marks obtained by the candidates in their qualifying examinations, the institute authorities are also required to verify all other documents in original with respect to his age, category, schooling district, etc. in consistent with the data available in the Merit Lists as well as in the Final Allotment Letter of the candidates. Upon successful verification of all these aspects, final admission of the candidates may be made.

# A. Candidates, who will take final admission against their allotted seat, will be advised to report at the concerned institution with the followings:—

- Two copies of Final Allotment Letter cum Money Receipt to confirm admission on or before the specified last date for respective phases. He/she has to pay admission related fees separately at the time of taking final admission at the allotted institute. The Government / Government Sponsored Institutions are required to collect fees from the students by following the guidelines depicted in Memo No. 960-TET dated 28.07.2023 of the Directorate of Technical Education & Training.
- Admission to the allotted seat is subject to successful verification of all relevant documents. Candidature is liable to be cancelled if a candidate fails to produce any of the documents in original before the verifying authority or produces fake documents at the time of admission and his/her allotted seat will be cancelled automatically.
- Last date of taking final admission at the Institute will be specified in the Allotment Letter. After the specified last date, Institute will not allow admission.
- Candidates have been asked to bring the following <u>documents in ORIGINAL</u> along with other documents and <u>a set of photocopies</u> of all documents for verification and submission at the time of admission:

#### For admission to 1<sup>st</sup> Year of Diploma Courses:

- Rank Card
- Final Allotment Letter
- Admit Card of Madhyamik or equivalent examination as age proof and for determination of

**District of Schooling** (in case a candidate is allotted District Quota seat) at Madhyamik or equivalent examination level. The Certificate of Madhyamik/Equivalent examination or Birth Registration Certificate will also be accepted as age proof.

- Mark sheet of Madhyamik or equivalent examination.
- Certificate relating to Reservation e.g. SC, ST, PC, OBC-A, OBC-B, LLQ, TFW, EXS, EWS (as applicable)

## For admission to 2<sup>nd</sup> Year of Diploma Courses:

- Rank Card
- Final Allotment Letter
- Admit Card / Certificate of Madhyamik / equivalent examination or Birth Registration Certificate.
- Mark sheet / Certificate of Higher Secondary <u>OR</u> 10+2 Board Examination <u>OR</u> HS (Vocational) of WBSCT&VE&SD <u>OR</u> equivalent examination <u>WITH any one of the subjects/areas</u> of Physics / Mathematics / Chemistry / Computer Science / Electronics / Information Technology / Biology / Informatics Practices / Biotechnology / Technical Vocational subject / Agriculture / Engineering Graphics / Business Studies / Entrepreneurship <u>OR</u> Pass 10<sup>th</sup> + (2 years ITI, continuous), in annual system or semester system
- Certificate relating to Reservation e.g. SC, ST, PC, EWS (as applicable)

# For both 1st & 2nd Year:

- SC / ST / OBC-A / OBC-B candidates are required to produce Caste Certificate issued by the competent authority of West Bengal, without which their claim for reserved seats under this category will not be entertained and thereby, allotment will be cancelled.
- Physically Challenged (PC) candidates are required to produce Physically Challenged Certificates (Minimum Disability: 40%; candidates having 100% disability are not allowed) issued by the competent authority at the time of admission without which their claim for reserved seats under this category will not be entertained and thereby, allotment will be cancelled.
- Migration or School Leaving Certificate for the students who passed their qualifying examination from the Board/Council of the State other than West Bengal or Central Board/Council.

#### For candidates allotted seats under Land Loser Category (For 1st Year Admission only):

The candidates opted for and allotted with "Land Loser" (LLQ) category seats will have to produce the relevant certificate issued by competent authority of the Government of West Bengal, without which such claim will not be entertained and thereby, allotment will be cancelled. Certificate issued in the name of parents / legal guardians by the BDO / SDO / First Class Magistrates / Group 'A' Gazetted Officers shall only be considered in this regard.

#### For candidates allotted seats under TFW Category (For 1<sup>st</sup> Year Admission only):

Candidates who are domiciled in West Bengal and whose annual family income from all sources during the financial year 2023-2024 is less than Rs.8.00 lakhs will be considered for admission under TFW scheme. For the purpose of determining the annual income of parents/guardian from all sources, an officer of the State Government in the rank of Block Development Officer or Sub-Divisional Officer or Additional District Magistrate or District / Group-A Gazetted Officer of the State or Central Government of similar rank or above in Commissionerate / Group-A Gazetted Officer of State or Central Government of similar rank or above in the urban region, will be competent to issue INCOME CERTIFICATE. It may be noted that Income Certificate issued by any other person will not be entertained in this regard.

For candidates allotted seats under "Wards of Ex-servicemen (EXS)" (For 1st Year Admission only):

- Must produce original documents in the name of his/her parents/legal guardian in respect of his/her claim as wards of ex-servicemen, otherwise such claim under this category will not be entertained and thereby, allotment will be cancelled.

For candidates allotted seats under "Economically Weaker Section (EWS)":

- Must produce relevant documents in original at the time of admission in respect of his/her claim, otherwise such claim will not be entertained and thereby, allotment will be cancelled. The eligibility criteria for EWS and the formats for submission of information in regard are furnished below.
- N.B. 1. In case of SC / ST / OBC-A / OBC-B / PC / TFW / LLQ / EXS / EWS candidates, who have been allotted a General Category seat, documents related to General Category seat have to be verified only.
  - **2.** *The District Quota* seats will be allotted based on the data provided by the candidates under "**District Schooling**" column. Candidates must pass Madhyamik or equivalent Examination from the district for which he/she claims district reservation facility. For determination of "District Schooling", admit card / certificate of Madhyamik or Equivalent Examination may be referred.

Candidates passed Madhyamik or equivalent Examination from the districts of Kolkata, North 24 Parganas, South 24 Parganas, Hooghly and Howrah will be allotted seats under 'KNSHH' zone. However, there will be **no District Quota seats** in the polytechnics located in the districts of Kolkata, South 24 Parganas, North 24 Parganas, Howrah and Sub-Divisions of Kalyani under Nadia District and Chandannagar, Serampore & Chinsurah under Hooghly District.

# B. All candidates, who will be allowed final admission, will have to submit the following documents in ORIGINAL:—

- Medical Fitness Certificate
- Anti-Ragging Affidavit
- Domicile Certificate

<u>Medical Fitness Certificate:</u> Candidates must satisfy medical fitness with reference to - (a) No Colour Blindness, (b) Physically & Mentally Fit, and (c) Able to pursue technical course. Candidates seeking admission to the courses under the WBSCT&VE&SD should possess good health and physique with sound mind. They should not be suffering from any disease / physical or mental infirmity. All candidates (including Physically Challenged) have to produce Medical Fitness Certificate mentioning the above criteria issued by the Registered Medical Practitioner, at the time of admission. Such Medical Certificate must possess signature, seal and registration number of the Medical Practitioner.

<u>Anti-Ragging Affidavit:</u> Filled-in Anti Ragging Affidavit in the prescribed format will have to be submitted in original at the time of taking final admission at the Institute.

**<u>Domicile Certificate:</u>** Filled-in Domicile Certificate in <u>any one of the three formats given</u> in the Information Brochure of JEXPO/VOCLET, shall have to be submitted in original at the time of taking final admission at the Institute.

All documents of a candidate should invariably be checked before offering provisional admission with respect to eligibility criteria, age, category, district schooling, etc. The category through which a candidate has been allotted the seat will be mentioned in his/her Allotment Letter. Documents in support of the category are to be checked and the candidate, if he/she fails to furnish any one of such documents, will not be allowed provisional admission. After verification of all testimonials in original, the institute authority will have to 'APPROVE' a provisionally admitted candidate through online portal of the Council within the stipulated time frame.

#### C. The Guidelines of checking all testimonials are as follows:-

- For candidates taking admission in 1st Year:
  - Candidates must pass Madhyamik Examination from West Bengal Board of Secondary Education or its equivalent examination from the Board/Council (List of recognized Board / Council is furnished below). *For this purpose, Mark Sheet of the qualifying examination of the candidate has to be checked.* In case of Grade Point, conversion formula of the concerned Board / Council has to be used.
  - There is no upper age limit. However, the candidate should not be born after 01.07.2009. For the purpose, Admit Card or Certificate of the qualifying examination or Birth Registration Certificate of the candidate has to be checked.
- For candidates taking admission in 2<sup>nd</sup> Year: Candidates must pass any one of the following examinations:—
  - Candidates must pass HS (Vocational) of WBSCT&VE&SD

#### OR

Candidates must pass 10+2 examination from the recognized Board/Council listed below, with **any one of the subjects/areas** of Physics / Mathematics / Chemistry / Computer Science / Electronics / Information Technology / Biology / Informatics Practices / Biotechnology / Technical Vocational Subject / Agriculture / Engineering Graphics / Business Studies / Entrepreneurship

#### OR

Candidates must pass  $10^{th}$  + (2 years ITI, continuous), in annual system or semester system, in any branch of Engineering and Technology.

- There is no age limit.
- Scheduled Caste / Scheduled Tribe certificate issued by the competent authority of the State of West Bengal against a candidate, allotted a seat under such quota will be valid only. SC/ST candidates having such certificates issued by the authorities of the States other than West Bengal are not eligible for such benefit. No candidate will be allowed admission in SC/ST quota unless he/she produces valid SC/ST certificate at the time of admission.
- Candidates, allotted seats reserved for Physically Challenged (PC) category, are eligible for seeking admission under PC Quota. <u>Candidates who obtained such certificates to this effect declaring the extent of 'Handicap' to be not less than 40% by the competent authority are eligible for admission under PC quota. Candidates having 100% disability are not allowed for admission. The certificate should be issued by any Government Hospital. No candidate will be allowed admission in PC quota unless he/she produces valid PC certificate at the time of admission.</u>

#### • For candidates allotted seats under Land Looser Category

Out of total approved seats, certain numbers of seats in Government & Government Sponsored polytechnics have been kept reserved under "Land Loser" (LLQ) category. Candidates opted for and allotted "Land Loser" (LLQ) category seats for 1<sup>st</sup> year admission will have to produce relevant certificate in original issued by the competent authority of Government of West Bengal at the time of admission, without which such claims will not be entertained and thereby, allotments will be treated as cancelled. Certificate issued in the name of parents/legal guardians of a candidate by the BDO / SDO / First Class Magistrates / Group 'A' Gazetted Officers shall only be considered.

#### • For candidates allotted seats under TFW Category

Candidates who are domiciled in West Bengal and whose annual family income from all sources during the financial year 2023-24 is less than Rs.8.00 lakhs will be allowed admission under TFW scheme. For the purpose of determining the annual income of parents/guardian from all sources, an officer of the State Government in the rank of Block Development Officer or Sub-Divisional Officer or Additional District Magistrate or District / Group-A Gazetted Officer of the State or Central Government of similar rank or above in the rural region or Executive Officer of Municipality / Assistant Commissioner or above in Commissionerate / Group-A Gazetted Officer of State or Central Government of similar rank or above in the urban region, will be competent to issue income certificate. *TFW Scheme is equally applicable for Government, Government Sponsored & Private Polytechnics*.

Candidates who have allotted seats under TFW quota will have to produce certificate in original at the time of admission without which such claim will not be entertained and thereby, his/her allotment will be treated as cancelled. *No amount towards 'Tuition Fee' from the allotted candidates under this category will be collected by the Institute.* 

#### For candidates allotted seats under EWS Category

The candidates who are domiciled in West Bengal and whose annual family income from all sources during the financial year 2023-24 is less than Rs.8.00 lakhs will be allowed admission under EWS scheme. For the purpose of determining the annual income of parents/guardian from all sources, an Income and Asset Certificate issued by any District Magistrate / Additional District Magistrate / Sub Divisional Officer / District Welfare Officer (DWO), Kolkata for Kolkata Municipal Area.

Candidates who have allotted seats under EWS quota will have to produce certificate in original at the time of admission without which such claim will not be entertained and thereby his/her allotment will be treated as cancelled.

N.B. If any minor discrepancy is observed in the Allotment Letter with respect to the Candidate's Name, Father's Name, Date of Birth, Aadhaar Number, etc., the same may be ignored and admission of such candidate may be made considering his original documents e.g. Admit Card or Certificate of Madhyamik or equivalent examination or Birth Registration Certificate, Aadhar Card, etc.

# SUMMARY

### For 1<sup>st</sup> Year Admission

- Check marks details of the candidate as per the eligibility criteria
- Check AGE of the candidate from his secondary admit card
- Check SCHOOLING DISTRICT of the candidate from the secondary admit card
- Must pass Madhyamik / Equivalent examination from the recognized Board/Council
- Studied English, Physical Science/Science/Science & Technology and Mathematics in secondary examination
- If allotted through reserved category, check relevant document and check the designation of the person issuing it is as per requirement
- Approve provisional admission of the candidate through council's web portal

## For 2<sup>nd</sup> Year Admission

- Check marks details of the candidate as per the eligibility criteria
- Check whether passed any of the examinations mentioned under eligibility
- If allotted through reserved category, check relevant document and check the designation of person issuing it is as per requirement
- Approve provisional admission of the candidate through council's web portal

## **ECONOMICALLY WEAKER SECTIONS (EWS)**

10% of seats are reserved for the candidates of Economically Weaker Sections (EWS) as specified in the Office Memorandum No. 325-PAR(AR)/3P-1/2019, dated 09/07/2019 of Government of West Bengal.

#### **Eligibility Criteria:**

- (a) Persons who are not covered under the scheme of reservation of SC, ST & OBC.
- (b) Gross Annual Family Income should be below Rs.8.00 lakh (Rupees eight lakh only). Income shall also include income from all sources i.e. salary, agriculture, business, profession etc. for the financial year prior to the year of application.
- (c) Persons whose families do not own or possess any of the following assets
  - a. 5 acres agricultural land and above.
  - b. Residential flat of 1000 sq. ft. and above.
  - c. Residential plot of 100 sq. yards and above in notified municipalities.
  - d. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

The property held by a family in different locations would be clubbed together for determining EWS status.

#### **Income and Asset Certificate Issuing Authority:**

The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by any of the following authorities in prescribed format as given in **Annexure-C**:

- 1. District Magistrate / Additional District Magistrate.
- 2. Sub-Divisional Officer.
- 3. DWO, Kolkata for Kolkata Municipal Corporation area.

Persons seeking Income and Asset Certificate shall apply in prescribed format in **Annexure-A** to the following authorities with supporting documents:

- 1. Block Development Officer of rural areas.
- 2. Sub-Divisional Officer for Municipalities.
- 3. DWO, Kolkata for Kolkata Municipal Corporation area.

List of supporting documents (illustrative and not exhaustive), self attested copies of which may be attached to the application for Income and Asset Certificate:

- a. EPIC or Citizenship Certificate of self or parents.
- b. PAN Card of self or parents
- c. Birth Certificate issued by the competent authority / Admit Cared or Certificate of Madhyamik or equivalent Examination.
- d. Pay Slip of self or parents.
- e. Income Certificate from prescribed authorities.
- f. Residential Certificate.
- g. RoR / Parcha / Registered Deed.
- h. Certificate in support of Sub-Caste from Pradhan of Gram Panchayat / Chairman of Municipalities / Councillor of Municipal Corporations.
- i. Self Declaration in regard of Family Income, Assets and Sub-Caste in the prescribed format in **Annexure-B**.
