**NOTIFICATION**

In exercise of powers conferred under Section 16 (xxiii), 16 (xxxi) of The West Bengal State Council of Technical and Vocational Education and Skill Development ACT, 2013 (West Bengal Act XXVI of 2013) read with Rule 12 (1) of the West Bengal State Council of Technical and Vocational Education and Skill Development (Transaction of Business and Finance, Accounts and Audit) Rules, 2019 read with AICTE Guideline (Appendix-I, Para 1.8), the Governor has been pleased to introduce the following guidelines for admission in various polytechnics & ITIs of the State as mentioned hereunder in partial modifications of the guidelines issued so far for the academic year, 2025.

1. Registration of candidates is ongoing through the Common Admission Portal (link: <https://scvtwb.in/>). All candidates who have registered earlier will be notified of the commencement of admission process.
2. The admission process shall commence from 15th April 2025, and the last date for application submission shall be 10th June 2025.
3. The admission to Polytechnics & ITIs shall be based on merit i.e. marks obtained in qualifying examination.
4. For the creation of the Merit List of Polytechnics & ITIs, weightage shall be given to marks scored in percentage, as follows: (a) For admissions where Class 10 is the minimum eligibility criteria: 50% weightage to total marks and 50% to marks obtained in Mathematics and Physical Science. (b) For admissions where Class 12 is the minimum eligibility criteria: 50% weightage to total marks and 50% to marks obtained in Mathematics + Physics/Biology + Chemistry. In case of tie, the subject marks will take precedence i.e marks obtained in Mathematics + Physical Science for Class 10 and



- marks obtained in Mathematics + Physics/Biology + Chemistry for Class 12.
5. There shall be 50% district quota for admission. The district quota will be brought under consideration as general seats at the end of second counselling. District quota will not be applicable to the districts of Kolkata, South 24 Parganas, North 24 Parganas, Howrah and Sub-Divisions namely, Kalyani under Nadia District and Chandannagar, Srirampur, Chinsurah under Hooghly District.
  6. Admission to the Polytechnics/ITIs in GTA Hill areas shall be made through the Common Admission Portal. Admission shall be kept restricted to residents of GTA hill area till 2nd counselling after which the vacant seats shall be brought under condition of General quota with hill students getting preference in admission.
  7. There will be 10% reservation for the Economically Weaker Sections (EWS) as per Memorandum No.TETSD-14057/1/2024-POLY-Dept. of TET&SD, dated 01.03.2024 issued by the Department of Technical Education, Training and Skill Development. The reservation for EWS shall be brought under General Seats after third counselling.
  8. Effort to convert SC/ST seats to General Seats with approval of competent authority may also be done after 3rd counselling.
  9. There will be reservation of 20% seats for female candidates uniformly in all categories, provided, if seats remain vacant after second counseling, those seats will be made open for respective category seats.
  10. Fee waiver will be allowed to the inmates of Homes of MEELS Department and WCD Department for admission to ITIs and Polytechnics as per this Department's earlier Notification No. I/358141/2023 dated 17.01.2023.
  11. Admission to Management quota/IMC quota as applicable will be open from the date of admission through the Portal.
  12. Mop Up/ Spot Counselling will be decentralized to the Institute Concerned, for which separate Notification shall be issued.
  13. All fees will be collected in online mode only. No cash transaction will be available.

14. Bangla Sahayata Kendras (BSKs) will be made official facility centres for registration and application.
15. Helpdesk cum Verification desk will be set up at all ITIs and Polytechnics from the start of admission process till closure of admission. Expenses for this purpose will be borne by the respective Councils.

In case any difficulty arises in implementation of the above guidelines, the matter may be raised to the notice of the Government for consideration and appropriate decision.

**CORRIGENDUM**

In partial modification of this Department's Notification No. I/628034/2025 dated: 08.04.2025, the Governor is pleased to amend the said Notification in the following manner:

1. Para no. 2 shall read as: "The admission process shall commence from 15th April 2025, and the last date for submission of online application shall be 10th June 2025.
2. Para no. 4 shall read as : "For the creation of the Merit List of Polytechnics & ITIs, weightage shall be given to marks scored in percentage, as follows: (a) For admissions where Class 10 is the minimum eligibility criteria: 50% weightage to total marks and 50% to marks obtained in Mathematics and Physical Science. (b) For admissions where Class 12 is the minimum eligibility criteria: 50% weightage to total marks and 50% to marks obtained in *Mathematics/Biology + Physics + Chemistry*.  
 In case of tie, the subject marks will take precedence i.e. marks obtained in Mathematics + Physical Science for Class 10 and marks obtained in Mathematics/Biology + Physics + Chemistry for Class 12. Further in case of tie, the candidate with the earlier date of birth will be given a higher rank."

Remaining portion of the said Notification shall remain unchanged.

**NOTIFICATION**


Notification for common admission in various polytechnics & ITIs for the academic year 2025 have been issued by this Department's Notification No. I/628034/2025 dated: 08.04.2025. According to the Para no. 6 of the said Notification:

*"Admission to the Polytechnics/ITIs in GTA Hill areas shall be made through the Common Admission Portal. Admission shall be kept restricted to residents of GTA hill area till 2nd counselling after which the vacant seats shall be brought under General category with hill students getting preference in admission".*

The above paragraph is further elaborated to ensure clarity in admission procedures in ITIs and Polytechnics institutes in the Hill areas.

1. Candidates of Hill Sub-Divisions aspiring admission in Polytechnics/ITIs are to submit their online applications through the Common Admission Portal of the Department (link: <https://scvtwb.in/>).
2. All eligible applicants of Hill Sub-Divisions shall get first priority for admission in the Polytechnics/ITIs located in Hill Sub-Divisions under GTA.
3. After allocation of seats to the applicants of Hill Sub-Divisions in the Polytechnics/ITIs under GTA, remaining vacant seats shall be offered to other candidates after the 2<sup>nd</sup> counselling for optimum utilization of the seats.
4. Preference of admission will be given to the applicants of GTA Hill Area even after the vacant seats are brought under General Category after 2<sup>nd</sup> Counselling.

All other guidelines outlined in this Department's Notification No. I/628034/2025 dated 08.04.2025 shall also apply to the GTA Hill areas.
