NOTIFICATION

After the Mop-UP counselling for ITI-E/ITI-M/Polytechnic 1st Year and Polytechnic 2nd Year , it has been decided that the remaining seats of Government and Government Sponsored Polytechnics as well as Government ITIs and Government ITIs running under PTP to be filled up through SPOT Counselling through Common Admission Portal (<https://admission-tetsd.wb.gov.in/>). The details procedure is stated below -

Eligibility for fresh Application in SPOT Counselling:

- All non-admitted candidates of the existing merit list , subject to fulfillment of the requisite eligibility criteria; and
- Fresh candidates fulfilling the prescribed eligibility criteria.

Steps of SPOT Counselling:

- Application Edit option will be allowed to the non-admitted students of Common Admission Portal, wherein candidates will be allowed to opt for de-reservation of their caste / quota, corrections of subject/marks/gender etc that were wrongly submitted by them earlier. No application fee will be received from this category of students **if paid earlier**.
- Fresh candidates shall be permitted to submit applications for any one of the following:
 - ITI-M;
 - Polytechnic 1st Year; or
 - Polytechnic 2nd Year,
- New Merit Lists for SPOT Counseling for ITI-M/ Polytechnic 1st Year / Polytechnic 2nd Year will be prepared considering Fresh Applications and Non-Admitted Applications (considering corrections etc, if any) without further verification at pre-allotment phase as per existing guidelines .
- In case of ITIs - The vacant E group trades will be opened for choice filling from the eligible M group candidates only.
- Choice Filling will be done by the new merit listed candidates covering max 03 institutes with any trade/course of those institutes only.
- Declaration of Allotment Result, Verification and Admission after payment, if applicable.
- The process will start from 23-Sep-2026.
